Anson Elementary School strongly encourages and welcomes the involvement of parent(s)/guardian(s) in all campus education programs. - Anson Head Start will inform parents, if appropriate, about ongoing professional development opportunities to enable K-2 children on the campus to meet Texas State Readiness and Gold Standards.
- AES teachers will provide handouts to parents regarding the content of the curriculum in their classrooms. In these handouts, the teacher will inform and involve parents in their student's assignments and requirements.
- AES will withdraw a student from any Safe and Drug-Free School curriculum upon receipt of request from the parents.
- AES will follow policies and practices consistent with the Family Education Rights and Privacy Act.
- Anson Elementary School requires teachers to discuss the Parent/School compact with the parents at the Meet the Teacher night. AES also ensures that teachers contact parents throughout the school year to keep them abreast of their child's performance.
- AES encourages parents to become involved with parent/school organizations such as fundraisers, class organization, and PTO.
- AES offers ESL classes to parents of the community with a prerequisite registration of at least 10.

- AES will provide assistance for parents to offer information about testing results, test-taking skills, and strategies for core subjects.
- AES will provide take-home materials for core subjects to enable parents to provide successful help at home.
- AES will send a folder home every Wednesday in order to communicate with parents about school issues and news, and parents can then communicate back with the teachers.
- AES provides a time for parents to register their child at a Kindergarten Roundup one evening at the end of school.
